

Goodwin makes the switch to TownSquare

You may have recently received an email from Goodwin & Co. giving you the opportunity to change the way you manage your HOA account. Goodwin has switched to a new software for managing all their community accounting, and members have been encouraged to follow the emailed instructions to set up their account on TownSq. Just use the username and password you received from Goodwin to begin the process of signing up. Once you are signed in, you will have the option of customizing your communication set-tings to receive notifications when and how you want. You can also update your mailing and email addresses to ensure you receive HOA communications. Remember to turn off any auto payments you may have previously set up once you set up new payments on the TownSq system. This will prevent duplicate payments, and you will no longer receive reminders from the previous system. 
Compliance Corner

Political Signage

Political signs are permitted under the following conditions:

- 1. Signs are not to exceed 2'x3' in area and should be fastened to the ground.
- 2. An Owner may only display signs political signs on property owned by them. (for example, signs are prohibited in common areas, outside of a fence/lot boundary line, etc.)
- 3. Political signs may only be displayed during the following time period: 90 days before the date of the election to which the sign relates, and 15 days after the election date.
- 4. Signs with exterior lights, sounds, or music are not permitted.

Per state law, the Association may remove and discard any sign displayed in violation of this rule.



Architectural Review Committee Volunteers Needed

The MOB Homeowners Association is currently seeking volunteers to join the Architectural Compliance Committee. The purpose of this particular committee is to assist the Board of Directors review and approve Architectural Applications that are submitted by MOB Residents. Responsibilities include:

- 1. Reading and understanding the Meadows of Blackhawk bylaws, resolutions and restrictions.
- 2. The ability to grant or not grant a ubmittal using said resolutions as a reference. No decision is to be made in regard to personal preference.

City News Waste Connection Limb Pickup

The Pflugerville City Council approved changes to the City's waste management contract, transferring the curbside chipping service to a limb pickup service by Waste Connections, the City's trash and recycling pickup provider, starting October 1, 2020. Pflugerville residential utility customers may continue to leave bundled limbs up to four feet in length curbside for free pickup on their trash day or take upto 2 cubic yards of limbs to the City's Recycle Center located at 15500 Sun Light Near Way free of charge. Starting October 1. Waste Connections will service unbundled tree limbs up to 4 cubic yards, that weigh less than 40lbs, and are no longer than four feet in length, for a flat fee of \$35.00/scheduled pick up.



City Parks and Library Begin Re-Opening



In response to Travis County moving into Stage 3 of Austin Public Health's risk-based guidelines, the City of Pflugerville Library and Parks and Recreation will reopen the following facilities and services effective Friday, August 28.

Parks and Recreation: Athletic fields, outdoor basketball courts, volleyball courts, Windermere tennis court, park open spaces and Lake Pflugerville Park. Library: The courtyard will reopen to the public. All other public spaces at the Library will remain closed. Please remember to continue to wear a face covering and practice social distancing.
